Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://fragosolegal.com> and Law Office of Jorge E. Fragoso and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Law Office of Jorge E. Fragoso include the following websites <https://fragosolegal.com>, www.mymexicanattorney.com, and www.lawmexican.com (collectively identified here as JEF). The JEF website is a Legal Services site and attorney advertisement. By using the JEF website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, JEF may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Consultations

If you purchase JEF's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

JEF collects and uses your personal information to operate its website(s) and deliver the services you have requested.

JEF may also use your personally identifiable information to inform you of other products or services available from JEF and its affiliates.

Sharing Information with Third Parties JEF does not sell, rent or lease its customer lists to third parties.

JEF may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to JEF, and they are required to maintain the confidentiality of your information.

JEF may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on JEF or the site; (b) protect and defend the rights or property of JEF; and/or (c) act under exigent circumstances to protect the personal safety of users of JEF, or the public.

Tracking User Behavior

JEF may keep track of the websites and pages our users visit within JEF, in order to determine what JEF services are the most popular. This data is used to deliver customized content and advertising within JEF to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by JEF. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the JEF website.

Use of Cookies

The JEF website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize JEF pages, or register with JEF site or services, a cookie helps JEF to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on.

When you return to the same JEF website, the information you previously provided can be retrieved, so you can easily use the JEF features that you customized.

- SSL Protocol

Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

Children Under Thirteen

JEF does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.

From time to time, JEF may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication.
